AGREEMENT TO PARTICIPATE; ASSUMPTION OF RISK AND RELEASE

(Please read and sign the following document)

Whereas, the undersigned (the "APPLICANT") wishes to be accepted for participation in YMCA Camp Carson's National Youth Project Using Mini-bikes (NYPUM) program to be organized by YMCA Camp Carson; and in consideration of YMCA Camp Carson's action in allowing the applicant to participate in such program:

The undersigned acknowledge(s) that during the said program that the Applicant has requested to participate in, that certain risks and dangers may occur. These include, but are not limited to the hazards of depending on other people, riding and operating motorized dirt bikes, being at various heights (ground to 55'), accident or illness in remote places without medical facilities, the forces of nature and travel by air, train ,boat, automobile or other conveyance. The undersigned further recognizes that these risks may also include loss or damage to personal property, physical or psychological damage and/or injury not excluding fatality due to accidents which may occur, including accidents resulting from this program or other type of outdoor activities. I further understand that in participating in these activities, I will be exposed to the elements of nature, including possible temperature extremes, and inclement weather. I understand that medical treatment may be several hours away in the event of a medical emergency.

In consideration of, and as part payment for the right to participate in such a program and the services and food arranged for me by YMCA Camp Carson & their Directors, YMCA of Southwestern Indiana, Inc. & their Directors, Officers, Employees, Agents, and/or Associates, and national NYPUM. I have and do hereby assume all the above risks and any other ordinary risk incidental to the program, including risks which are not specifically foreseeable, and will hold them harmless from any and all liability, actions, causes of action, debts, claims, and demands of every kind and nature whatsoever. Whether from bodily injury, property damage or loss or otherwise, which I now have or may arise from or in connection with my program or participation in any other activities arranged for me by YMCA Camp Carson, their Directors, Officers, Employees, Agents, and/or Associates, and their heirs, executors, and administrators, and national NYPUM. The terms hereof, and my signature on this document shall serve as a release and assumption of risk, and shall bind my heirs, representatives, executors, administrators, successors and assigns for all members of my family, including any minors accompanying me. I also state that I am not under, and will not be under the influence of any chemical substance including alcohol. I fully understand that any physical activity involves risk of injury. I also understand that my participation in this YMCA Camp Carson Program is entirely **VOLUNTARY**. I agree and hereby state that I am solely responsible for my own participation and for my own physical and emotional well being. I am aware that all of the program activities are strictly voluntary and it is my own choice to participate in each activity to whatever degree I deem appropriate, after due consideration of my own physical health, physical abilities and medical condition.

This release does not, however, apply to any physical injury or emotional harm caused by negligence or willful misconduct of YMCA Camp Carson, their Directors, Officers, Employees, Agents, and/or Associates, and their heirs, executors, and administrators, and national NYPUM.
